Term and conditions to be followed by the firm are given below:

1. Last date to submit quotation will be 01:30 pm 06-07-2026.
2. No quotation will be entertained after the final date.
3. Quotation must be inclusive of all taxes and in sealed envelope.
4. In case any new tax will be received from government (it will be applicable as per actual begin)
5. Quotation must contain acceptance of all the terms and conditions as under in writing.
6. All the faulty cameras should be repaired within 72 hours after lodging the complaint. The mechanic must visit PRTC Head Office, Nabha road, Patiala for service, repair, and maintenance of all the cameras. In case any camera remains non-Functional for more than 72 hours after lodging of the complaint the penalty will be Rs. 20/- per camera per day.
7. Payment to the firm will be made on monthly basis at the end of each month after submission of bills.
8. In case of damage, and if part needs to be replaced, material must be provided by the firm at quoted rates.
9. The company shall pay security amount of 20 % amount of total AMC value- in form of Bank Guarantee/ Demand Draft valid for period of 15 months starting from AMC period.
10. Service Engineer/ Representative of firm must visit once in a week for general checking and service in working days.
11. If during AMC period any equipment needs to be replaced, a joint inspection committee (representative of the firm, IT Cell, operation cell or Civil Cell) will take the decision.
12. MD, PRTC reserves the right to include or exclude any condition or to modify or alter the condition at any time during the AMC contract period with mutual consent.
13. All disputes arising out of or in any way touching or concerning this agreement, whatsoever shall be referred to the sole arbitration if the MD, PRTC acting as such at the time of reference PRTC and the company both agree to accept MD, PRTC or his nominee as the sole Arbitration specified under this agreement.
14. The court at Patiala only shall have the jurisdiction for the purpose of this agreement.
